Public Comment:

Tory Knutson came to ask the board for a scholarship to be able to play in the B League. She is a college student who would like to continue to play since taking up hockey last year.

Christy motioned for Tory to receive the scholarship for league fees but Tory will be responsible for her own USA hockey insurance. Tory will work off the dollar amount by helping Tony with Rink cleaning and maintenance. Tony will keep track of the hours at \$8 per hour for 17 hours.

Christianne seconded. Passed unanimously.

Sean Page also requested a scholarship being a college student and long standing SIHL player. Tony agreed to let him work on rink maintenance as well, at \$8 per hour for 17 hours.

Christy motioned for Sean to be able to receive a scholarship, with responsibility to obtain USA hockey insurance and work under the Rink Facility Manager, Tony Mariskanish. Christianne seconded, passed unanimously.

Rink set up will begin 9:00 a.m Saturday morning Oct. 11, meet at the rink.

Registration is still low in comparable to last year. Will have registration during open skates, past coaches can call old players and let them know sign ups are going on.

Christy motioned for Russ Law a former board member to be able to have a key to do "lunch time" hockey for non-members w/ USA hockey insurance, to help potential players learn skills and the game. Pam seconded, passes unanimously.

Tim reported that feedback on rules changes for A or B league players has been mostly positive. Has been asking for volunteers to come to the rink set up on Sat.

Dan would like to have a general ref meeting as soon as the rink is set up. Also suggested that working off League fees by being a ref should have started within the first two months of League play.

Tony will be cleaning the rink floor weekly on Mon and Fri. a.m. with a possibility to have it cleaned on Wed. with the help of Shawn and Tori. This is working with their class and job schedules.

July Wright applied for a scholarship for her son DJ Malone. She can score keep DJ's games and DJ can score keep other games to work off the fees. Christianne motioned to approve the scholarship, Brenda seconded, passed unanimously.
